Research and Policy Analyst Position Description

This position will provide an aspiring analyst with an exceptional opportunity to demonstrate and develop their skills as part of a small but high-impact and hard-working team.

EIG's Research and Policy Analyst will play an integral role in devising and executing a thought-provoking research agenda that directly informs creative, actionable policy proposals to reinvigorate the dynamism of the U.S. economy. The analyst will be deeply involved in all aspects of creating and communicating research products. Candidates with well-rounded backgrounds in economic development, entrepreneurship, geography, urban studies, and applicable economic and innovation policy areas are encouraged to apply. Direct policy experience in local, state, or federal government is also welcome.

The Research and Policy Analyst will perform the following duties (percentages are approximate):

40% Quantitative and qualitative economic and public policy research:

- Draw on a deep knowledge of economic geography and economic development theory, policy, and practice, to bear in informing EIG research and policy products.
- Utilize various public and private datasets to conduct advanced data and statistical analysis on U.S. economic trends.
- Conduct literature reviews, stakeholder interviews, policy evaluations, and qualitative research to inform public policy recommendations and practitioner handbooks.
- Research state and local policies in the realms of entrepreneurship, access to capital, human capital, and other issues.
- Stay immersed in the scholarly and academic research across all relevant fields to ensure that EIG research and analysis remains on the cutting edge.
- Manage the processing and development of large flagship EIG datasets such as the Distressed Communities Index.
- Create new data products in EIG's core issue areas such as Opportunity Zones, community economic well-being, and entrepreneurship.

30% Research and policy writing:



- Write large sections of marquee EIG reports analyzing both proprietary and publicly available data.
- Write policy memos, briefs, and handbooks for key audiences that translate data insights into actionable policy recommendations.
- Independently devise and author incisive short pieces in EIG's core issue areas.
- Draft persuasive pieces such as op-eds or essays in EIG's core issue areas.
- Synthesize EIG's research and policy insights into products tailored to different audiences.

15% Economic data visualization:

- Utilize mapping and data visualization software to bring EIG's data to life.
- Train in new software and capabilities as needed.

15% Outreach and network management:

- Liaise directly with congressional staff, state government officials, and local government representatives to share EIG data and insights and feed back into EIG key issues and concerns facing public leaders.
- Build and maintain a network of state and local economic development leaders interested in EIG's work by participating in calls, webinars, and written exchanges sharing EIG's data and expertise.
- Present to external audiences on behalf of EIG and represent the organization at conferences and other venues.
- Respond to stakeholder and media requests for data and information as needed.
